## Division – B-Linda Brumder

DISCUSSION	A match at MAC against LO had not been completed within the allotted court time. Fortunately, a MAC member relinquished his court to allow the match to finish. The captain asked for clarification as to how to proceed when a match lasts longer than the allotted court time. Page 10 in the Rules states: "Home teams unable to provide adequate court time will retire matches not completed due to lack of courts."
CONCLUSIONS	We will consider adding options to speed up play (for example, not switching courts after odd games) in the Rules and the FAQs.
	A captain had not received confirmation of a player addition at mid-season and was confused about the March 28 <sup>th</sup> deadline for adding players.
	Jian will confirm player addition at mid-season. Linda will send email clarifying March 28 <sup>th</sup> deadline.
	In a match between Salem and MPRC, the singles player requested all three balls when she served. The MPRC player refused to accommodate the request. After two games the Salem player chose to retire the match. The board discussed why the request was not accommodated.
	There was no rules violation as the MPRC player did not have to comply with the request unless the 3rd ball was readily available. Distant balls shall be retrieved at the end of a game, per USTA Code. The rules committee will review.

## **<u>Division – D – Barb Schmitz</u>**

DISCUSSION	A player was not listed as a possible sub when a captain was inputting the scores.
CONCLUSION	Jian will investigate. It is most likely that the name was misspelled. Both captains should submit a copy of their scoresheets to the division rep and Jian to verify if name misspelled or a potential illegal player.

## <u>Division – E – Alisa Rakoz</u>

DISCUSSION	A captain reported a problem with a ball rolling onto a court during play and requested a

	From USTA Code: "When a ball from another court enters the playing area, any player on the
CONCLUSIONS	court affected may call a let as soon as the player becomes aware of the ball. The player loses the
	right to call a let if the player unreasonably delays in making the call."

C	Nikki passed out sample questions for a survey on the singles position in City League matches. The board discussed the reason for the survey, the best method for distributing the questions, and
	how the results will be utilized.

After a lengthy discussion, the board decided to send out the survey to gather information only. No changes to the league will be made this year.
